Changes in Agricultural Infrastructure and Development Cess (AIDC) with effect from 02.02.2026

Changes in AIDC WEF 02.02.2026

- ⌚ The rate of AIDC on new pneumatic aircraft tyres (CTH 4011 30 00) remains unchanged and continues to apply at 0.5% except where the goods attract NIL BCD under S. Nos. 155 and 156 of Notification No. 45/2025-Customs dated 24.10.2025
- ⌚ The amendment effective 02.02.2026 merely removes the reference to S. No. 157 of Notification No. 45/2025-Customs dated 24.10.2025 (since that entry has been omitted) and does not alter the effective duty structure

AMENDMENT TO RULES UNDER CUSTOMS ACT, 1962

Amendments to Baggage Rules & Deferred Payment Mechanism

- 🕒 The Baggage Rules, 2016 are being superseded by the Baggage Rules, 2026 to rationalize passenger-related provisions, clarify temporary import/export of personal goods, and restructure Transfer of Residence benefits based on duration of stay, effective midnight 02.02.2026
- 🕒 The Deferred Payment of Import Duty framework is being amended to introduce monthly duty payment (in place of the earlier 15-day cycle) and to create a new category of 'eligible importers' under the Deferred Payment of Import Duty Rules, 2016

Other Notification changes with effect from 02.02.2026

- 🕒 **Clean Energy:** BCD exemption on capital goods for Lithium-Ion cell manufacturing has been extended to cover Battery Energy Storage Systems (BESS) under Notification No. 25/2002 dated 01.03.2002, effective from 02.02.2026
- 🕒 **Defense & Aviation:** Under Notification No. 45/2025, BCD exemption has been introduced for
 - Raw materials used in the manufacture of aircraft parts, engines and components for Maintenance Repairs Overhauling by Defence Public Sector Units, subject to Import of Goods at Concessional Rate of Duty or for Specified End Use Rules, 2022 (IGCRS Rules) and end-use certification, and
 - Components and parts, including engines, for manufacture of aircraft and parts thereof, subject to IGCRS Rules, 2022, with effect from 02.02.2026.

...Other amendments in Customs Act...

- ⌚ **Nuclear & Healthcare (effective from 02.02.2026):** Notification No. 45/2025 dated 24.10.2025 has been expanded to extend customs duty exemptions in respect of the following:
 - Specified nuclear power projects, irrespective of capacity, with validity extended up to 30.09.2035, including contracts registered up to that date
 - Additional 17 new drugs/ medicines
 - Additional 7 rare diseases under National Policy for Rare Disease, 2021 on drugs, medicines and food for special medical purposes when imported for personal use
- ⌚ **Review of Customs Duty exemptions:** Pursuant to a comprehensive review of exemptions under Notification No. 45/2025-Customs dated 24.10.2025, certain conditional exemption / concessional duty entries have been extended up to 31.03.2028, while others have been allowed to lapse on 31.03.2026; additionally, some unconditional exemptions have been omitted with effect from 02.02.2026.

⌚ Critical Minerals Rationalization:

- Certain exemption entries of Notification No. 36/2024 dated 23.07.2024 have been shifted to the Customs Tariff with effect from 01.05.2026 and Certain redundant entries of Notification No. 36/2024 dated 23.07.2024 have been omitted with effect from 02.02.2026
- Certain exemption entries relating to specified critical minerals have been shifted to the rate notification

AMENDMENTS IN CENTRAL EXCISE LAW

Revision of Statutory NCCD Rates on Specified Tobacco Products

- With effect from 01.05.2026, the Seventh Schedule to the Finance Act, 2001 is proposed to be amended to revise the statutory National Calamity Contingent Duty (NCCD) rates on the following tobacco products:

Tariff Item	Description	Existing NCCD	Revised NCCD
2403 99 10	Chewing tobacco	25%	60%
2403 99 30	Jarda scented tobacco	25%	60%
2403 99 90	Other tobacco products (including gutkha)	25%	60%

- Note:** The effective NCCD rate will continue at 25% through a corresponding notification

- ⌚ The value of Biogas/Compressed Biogas (CBG) in blended Compressed Natural Gas (CNG), along with the GST paid on it, will not be included for calculating Central Excise duty on blended CNG.
- ⌚ Notification No. 11/2017-Central Excise dated 30.06.2027 is amended accordingly w.e.f. 02.02.2026.
- ⌚ Notification No. 05/2023-Central Excise dated 01.02.2023, which earlier allowed exemption only for the GST portion on biogas/CBG, is being withdrawn from the same date.

Postponement of Implementation of Higher Excise Duty on Sale of Unblended Diesel

- ⌚ The scheduled introduction of an additional excise duty of Rs. 2 per litre on unblended diesel, originally provided under Notification No. 11/2017-Central Excise dated 30.06.2027, has been deferred until 31.03.2028 by an amendment made through Notification No. 02/2026-Central Excise dated 01.02.2026






